The Supplement has been prepared in accordance with Article 23 of the Regulation (EU) 2017/1129 of the European Parliament and of the Council (the "**Prospectus Regulation**") and was approved by the Swedish Financial Supervisory Authority on 2 December 2021 (Swedish Financial Supervisory Authority reference number 21-31706). The Supplement was published by the Company on the same day.
